

Crozet Arts Covid-19 Protocols & Waiver

Signature required of parent or student (if over age 18) prior to class or workshop session.

Please read the information below and then sign this waiver prior to participating in class(es) at Crozet Arts. This waiver pertains to 1 September 2021 - 30 June 2022 classes, workshops, or other meetings at Crozet Arts.

CROZET ARTS COVID-19 ABATEMENT STEPS:

- Adherence to CDC and Blue Ridge Health Department recommendations for surface cleaning and air exchange
- In-depth consultations with our medical advisors
- Installation of an ALEN air purifier in each studio, and hallway, running 24/7 for air filtration
- New A/C units installed in each studio
- Water pipes flushed and water testing in bathrooms
- Taped-off individual floor and barre spaces for students in the Dance Studio
- Individual workplaces in the Art Studio, with 6' distancing
- Classrooms will allow for distancing at all times; protocols will vary for different kinds of classes.
- Supplies will be unique per student; any shared art tools, or ballet barres, will be sanitized between students/classes.

COVID PROTOCOLS FOR CROZET ARTS CLASSES/WORKSHOPS/MEETINGS:

- **Masks must be worn by everyone over the age of 2 to enter, and while inside, Crozet Arts.**
- Students exhibiting signs of illness should remain at home (please email CrozetArts@gmail.com to report illness to Sharon Tolczyk). Symptoms include, but are not limited to the following:
 - Fever or chills
 - Cough
 - Shortness of breath or difficulty breathing
 - Muscle or body aches
 - Headache
 - New loss of taste or smell
 - Sore Throat
 - Nausea or vomiting
 - Diarrhea
 - Congestion or runny nose (other than caused by known allergies)

PLEASE NOTE: Your signature at the bottom of this document commits student (or parent, if student is under age 18), to monitoring health symptoms before EACH Crozet Arts class and agreeing *not to attend* if symptoms are present.

●●●> If a Crozet Arts student/attendee, student's/attendee's household member, or anyone accompanying a student/attendee inside CA, tests positive for Covid-19, please notify Sharon Tolczyk (CrozetArts@gmail.com). Confidentiality will be maintained; we will contact the Blue Ridge Health Department and follow directives for contact tracing & quarantining as needed. Please see COVID-19 information on our website for requirements for returning to Crozet Arts following quarantine or a Covid-19 diagnosis.

- Please use hand sanitizer in hallway upon entering.
- Students and teachers will wear masks throughout class, other than for distanced water & snack breaks.
- Parents should check-in and pick-up students according to class protocols (see email sent prior to class session for details). Except for students ages 3-6, parents are asked not to wait in the hallways during class; after class, students will be walked out to the steps to meet parents; or, parents may be invited by teacher at the end of class to come in and pick-up students.

I understand and acknowledge that Crozet Arts cannot eliminate the risk of exposure to COVID-19, or other communicable diseases, and by signing this **HOLD HARMLESS, RELEASE, AND WAIVER OF LIABILITY AGREEMENT**, I fully and knowingly agree to ASSUME ALL RISKS associated with participating in Crozet Arts classes, workshops, or meetings and the exposure to or the infection of COVID-19, including any risk of illness, bodily injury, permanent disability, and/or death related, directly or indirectly, to COVID-19.

I agree that this **HOLD HARMLESS, RELEASE, AND WAIVER OF LIABILITY AGREEMENT** is to be binding upon my spouse, children, heirs and assigns, and that the provisions contained herein shall be construed, interpreted and controlled according to the laws of the Commonwealth of Virginia.
